CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated June 16, 2025, placed the rating(s) of Bisui Poultry Private Limited (BPPL) under the 'issuer non-cooperating' category as BPPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. BPPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated May 02, 2026, May 12, 2026, May 22, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Incorporated in January 2012, Bisui Poultry Private Limited (BPPL) was promoted by the Bisui family based out of Paschim Medinipur West Bengal. BPPL is engaged in the business of layer poultry farming and involved in sales of eggs and birds. The poultry farm has a total capacity of layer birds is improved from 70,000 to 1,50,000 after completion of expansion project with facilities located at Bankura, West Bengal.

Status of non-cooperation with previous CRA: ICRA has continued the rating assigned to the bank facilities of BPPL into ISSUER NOT COOPERATING category vide press release dated February 16, 2026 on account of its inability to carry out a review in the absence of requisite information from the company.
