Rationale and key rating drivers

CARE Ratings Ltd. (CareEdge Ratings) had, vide its press release dated April 29, 2025, placed the rating(s) of JP Dyechem Private Limited (JDPL) under the 'issuer non-cooperating' category as JDPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. JDPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 15, 2026, March 26, 2026, April 04, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

The company has been engaged in the business of importing and distribution of Monomers, Acrylates, Glycols, Anhydrides, Flame Retardant chemicals & Specialty chemicals. The company is also the authorized distributor of "Supreme Petrochem Limited" for polystyrene products. The company has five warehouses in Maharashtra, Gujarat, Karnataka, Tamil Nadu and West Bengal.
