Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated May 08, 2025, placed the rating(s) of Purvanchal Agrico Private Limited (PAPL) under the 'issuer non-cooperating' category as PAPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. PAPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 24, 2026, April 03, 2026, April 14, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

About the company

Purvanchal Agrico Private Limited (PAPL) is a private limited company incorporated in March 31, 2008. The company is promoted by Mr. Om Prakash Rai and Mr. Suvrat Shahi. PAPL is engaged in renting of its cold storage facility for potatoes and tomatoes to the local farmers in Varanasi with multi chambers. PAPL is also engaged in the business of processing of milk and manufacturing of milk products at its plant at Inayatpur, Ghazipur, Uttar Pradesh. Various products available in the portfolio of the company are skimmed milk powder (SMP), whole milk powder (WMP), dairy whitener (DW), butter, ghee and other milk products.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of PAPL into Issuer Not Cooperating category vide press release dated April 28, 2026 on account of its inability to carry out a review in the absence of requisite information.
