Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated April 28, 2025, placed the rating(s) of JDC India Limited (JIL) under the 'issuer non-cooperating' category as JIL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. JIL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated March 14, 2026, March 24, 2026, April 03, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings opinion is not sufficient to arrive at a fair rating.

About the company

JDC India Limited was incorporated in October 24, 1995 with an objective to enter into the rice milling and processing business. However, after remaining dormant for a few years, the company started its commercial operations from 2006. The manufacturing unit of the company is located at Ausgram, Burdwan, West Bengal. The current installed capacity of the unit is 24,000 tons per annum. The entity is procuring raw paddy from the local farmers. The company also has a cold storage facility in Ausgram for potato traders and farmers. This apart, it also exports electrical goods to Doha, Qatar. Mr. Ajoy Kumar Basu and Mr. Asim Kumar Bose both having almost four decades of experience in similar line of business, looks after the day to day operation of the company along with other directors and a team of experienced professionals who have rich experience in the similar line of business.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of JIL into ISSUER NOT COOPERATING category vide press release dated December 11, 2025 on account of its inability to carry out a review in the absence of requisite information from the company.

Acuite has continued the rating assigned to the bank facilities of JIL into ISSUER NOT COOPERATING category vide press release dated January 05, 2026 on account of its inability to carry out a review in the absence of requisite information from the company.
