Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated July 10, 2025, placed the rating(s) of Puspa Agencies Private Limited (PAPL) under the 'issuer non-cooperating' category as PAPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. PAPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated May 26, 2026, June 05, 2026, June 15, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

The ratings assigned to the bank facilities of PAPL have been revised on account of non-availability of requisite information.

About the company

Puspa Agencies Private Limited (PAPL) was incorporated on June 30, 2006 by Mr. Narottam Patra and Mrs. Subhadarshinee Sanghamitra Patra (wife of Mr. Narottam Patra). Since its inception, the company has been engaged in rice milling and processing business. The milling and processing plant of the company is located at Cuttack, Odisha with aggregate installed capacity of 96,000 metric ton per annum (MTPA). Apart from own milling and processing of rice, the company is also engaged in custom milling for state government.
