Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated August 06, 2025, placed the rating(s) of Erode Sri Palani Murugan Spinning Mills Private Limited (ESPMSMPL) under the 'issuer non-cooperating' category as ESPMSMPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. ESPMSMPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 22, 2026, July 02, 2026, July 12, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

About the company

Erode Sri Palani Murugan Spinning Mills Private Limited (ESPMSMPL) is a Tamil Nadu based company, which was incorporated in 2006 and promoted by Mr. E. Palanisamy and others as a Private Limited company. The company is engaged in manufacturing of cotton yarn (30-46 counts) with a total installed capacity of 13,824 spindles at its manufacturing unit located at Erode, Tamil Nadu. The manufacturing process includes ginning of raw cotton, blending, carding, combing, drawing out, twisting and spinning. The company is also engaged in manufacturing of cloth at its weaving mill from rayon yarn.

Status of non-cooperation with previous CRA: Brickwork has continued the ratings assigned to the bank facilities of ESPMSMPL to the 'issuer not-cooperating' category vide press release dated April 10, 2026 on account of its inability to carryout review in the absence of requisite information from the company.

CRISIL has continued the ratings assigned to the bank facilities of ESPMSMPL to the 'issuer not-cooperating' category vide press release dated June 25, 2026 on account of its inability to carryout review in the absence of requisite information from the company.
