Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated July 24, 2025, placed the rating(s) of Radharaman Stainless Steel Private Limited (RSSPL) under the 'issuer non-cooperating' category as RSSPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. RSSPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 09, 2026, June 19, 2026, June 29, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Radharaman Stainless Steel Private Limited (RSSPL) was incorporated in the year 1985 as a private limited company and is managed by Mr. Purushottam Dass Garg and Mrs. Anita Garg who are having more than three decades of experience in the business. RSSPL is engaged in the business of manufacturing of stainless-steel sheets and circle of different measurements as per the requirement of clients. Company purchases steel coils from suppliers located in domestic market and sells its products to wholesalers of cutlery and utensil manufacturers. Company has its registered office and processing plant in Alwar, Rajasthan.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of RSSPL into Issuer Not Cooperating category vide press release dated December 22, 2025 on account of its inability to carry out a review in the absence of requisite information.
