Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated August 01, 2025, placed the rating(s) of Rajeshwar Poultry & Hatcheries (RPH) under the 'issuer non-cooperating' category as RPH had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. RPH continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 17, 2026, June 29, 2026, July 07, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.
