Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated August 04, 2025, placed the rating(s) of Satkartar Electricals & Electronics Private Limited (SEEPL) under the 'issuer non-cooperating' category as SEEPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SEEPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 20, 2026, June 30, 2026, July 10, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

About the company

Delhi based Satkartar Electricals and Electronics Private Limited (SEEPL) is a private limited company, incorporated on October 10, 2005. However, the company has started its commercial operation since April 2017. SEEPL is being promoted by Mr. Kuldeep Singh, Mr. Harjot Singh and Ms. Sarandeep Kaur. SEEPL is an electrical contractor engaged in providing building wire fitting services, LT panel installation, electrical transformer installation, bulb fittings and wiring services for real-estate buildings.

Status of non-cooperation with previous CRA: CRISIL has continued the ratings assigned to the bank facilities of SEEPL into 'Issuer not-cooperating' category vide press release dated April 30, 2026 on account of non-availability of requisite information from the company.

INFOMERICS has continued the ratings assigned to the bank facilities of SEEPL into 'Issuer not-cooperating' category vide press release dated November 18, 2025 on account of non-availability of requisite information from the company.
