### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated July 24, 2025, placed the rating(s) of B D Agricare Private Limited (BDAPL) under the 'issuer non-cooperating' category as BDAPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. BDAPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 09, 2026, June 19, 2026, June 29, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Uttar Pradesh based B.D. Agricare Private Limited (BDAPL) was incorporated as a private limited company in August 2011. The company commenced its operations in August, 2013 and is currently being managed by Mr. Adarsh Gupta. It is engaged in processing rice and its by-products by processing paddy, in its processing unit located in Village Gaukhor, Basti.

**Status of non-cooperation with previous CRA:** CRISIL has continued the ratings assigned to the bank facilities of BDAPL into 'Issuer not-cooperating' category vide press release dated June 25, 2025 on account of non-availability of requisite information from the company.
