Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated July 28, 2025, placed the rating(s) of BBG Infrastructure Private Limited (BIPL) under the 'issuer non-cooperating' category as BIPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. BIPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 13, 2026, June 24, 2026, July 03, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

The ratings assigned to the bank facilities of BIPL have been revised on account of non-availability of requisite information.

BIPL has been primarily constructing transportation projects and urban Infrastructure. BIPL started off with working as subcontractor and took on the execution of balance work for metro stations in Noida and Ghaziabad. Later, after acquiring the required technical qualifications, they started bidding as main contractors for Pune and Nagpur metro projects. They have executed balance work on metro stations such as Prajapati Nagar, Raj Bagh, Rajinder Nagar, Noida Sector 59 and 62 etc.
