Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated August 11, 2025, placed the rating(s) of Om Sharda Logistics Private Limited (OSLPL) under the 'issuer non-cooperating' category as OSLPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. OSLPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 29, 2026, July 07, 2026, July 17, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

The ratings assigned to the bank facilities of OSLPL have been revised on account of non-availability of requisite information.

Incorporated in May 2007, OSLPL was promoted by the Kabra family of Jamshedpur (Jharkhand). Since its inception, the company is engaged in surface transport business mainly for the minerals and iron ore/steel industry. OSLPL participates in tenders to secure work contracts floated by various Govt. undertaking entities. Currently the company has work orders only from Damodar Valley Corporation for loading and transportation of coal by road with dumper/tipper.
