Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated July 30, 2025, placed the rating(s) of Ashiana Manufacturing India Limited (AMIL) under the 'issuer non-cooperating' category as AMIL had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. AMIL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 15, 2026, June 25, 2026, July 05, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

The ratings assigned to the bank facilities of AMIL have been revised on account of non-availability of requisite information.

Ltd. (AIPL) and AMIL. Post that, Mr. Neeraj Kumar Jain started looking after AMIL independently while AIPL is managed by Mr. Naresh Chand Jain. AMIL is engaged in the business of manufacturing and selling of TMT bars from ingots and billets. AMIL's manufacturing unit is located in Bhiwadi, Rajasthan. AMIL sells of its products across 3 states in India and the distribution channel is managed by KDL
