Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated August 06, 2025, placed the rating(s) of R. K. Frozen Foods (RKFF) under the 'issuer non-cooperating' category as RKFF had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. RKFF continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 22, 2026, July 02, 2026, July 12, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Kashipur based, R.K. Frozen Foods (RKFF) is a partnership concern established in April 2009 by Mr. Ajay Kumar Agarwal and Ms. Priti Agarwal. RKFF is engaged in processing fresh fruits & vegetables into frozen form through individual quick freezing (IQF) technique. RKFF has set up its manufacturing facility at Udham Singh Nagar, Uttarakhand.

Status of non-cooperation with previous CRA: Brickwork has continued the rating assigned to the bank facilities of RKFF into Issuer Not Cooperating category vide press release dated May 18, 2026 on account of its inability to carry out a review in the absence of requisite information.
