Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated August 04, 2025, placed the rating(s) of Shivam Pipe Industries (SPI) under the 'issuer non-cooperating' category as SPI had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SPI continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 20, 2026, June 30, 2026, July 10, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Guwahati based Shivam Pipe Industries (SPI) was established as a partnership firm in 2009. However, it has commenced its operation from April 2012. The firm has been engaged in manufacturing of ERW pipes and steel tubular pole (MS & GI) with a production capacity of 12,000 MTPA and 5,000 MTPA respectively at its plant located at Kamalpur in Guwahati

Status of non-cooperation with previous CRA: ICRA has continued the rating assigned to the bank facilities of SPI into Issuer Not Cooperating category vide press release dated December 18, 2025 on account of its inability to carry out a review in the absence of requisite information
