Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated July 24, 2025, placed the rating(s) of Sadguru Engineers & Allied Services Private Limited (SEASPL) under the 'issuer non-cooperating' category as SEASPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SEASPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 09, 2026, June 19, 2026, June 29, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

The ratings assigned to the bank facilities of SEASPL have been revised on account of non-availability of requisite information.

About the company

Incorporated in August 2011, Sadguru Engineers and Allied Services Private Limited (SEASPL) is engaged in civil construction projects, primarily building and road construction, for Engineering Projects India Ltd (EPIL), Indian Oil Corporation Ltd. (IOCL) and Public Works Department (PWD). The company was earlier set up as a proprietorship concern by Mrs. Rumi Jalan in the year 2007.

Status of non-cooperation with previous CRA: Brickwork has continued the ratings assigned to the bank facilities of SEASPL in the Issuer Non-cooperation category vide Press release dated June 26, 2025 on account of its inability to carry out a review in the absence of requisite information from the company.
