Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated July 23, 2025, placed the rating(s) of Kamakshi Steels Private Limited (KSPL) under the 'issuer non-cooperating' category as KSPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. KSPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 08, 2026, June 18, 2026, June 29, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

About the company

Kamakshi Steels Private Limited (KSPL) was incorporated in December 16, 2003 and is engaged in manufacturing of TMT Rebars and Billets with installed capacity of 36,000 MTPA (for TMT Rebars) at its facilities located at Krishna District, Andhra Pradesh. The TMT Rebar forms major sales component (around 95%) with majority of billets utilized for captive consumption and balance sold in the market. The company produces TMT bars of various sizes viz. 8mm, 10mm, 16mm, 20 mm and 25mm, as per requirements of client. The company usually caters to coastal regions of Andhra Pradesh viz Krishna District, West Godavari, Guntur, Nellore, Chittoor and Prakasham District.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of KSPL into Issuer Not Cooperating category vide press release dated September 25, 2025 on account of its inability to carry out a review in the absence of requisite information.
