Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated July 18, 2025, placed the rating(s) of Purewal Stone Crusher (PSC) under the 'issuer non-cooperating' category as PSC had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. PSC continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 03, 2026, June 13, 2026, June 25, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Nainital, Uttarakhand based, Purewal Stone Crusher (PSC) was established in year 2013 and the commercial operations started from March, 2015. It is currently managed by Mr. Dilbag Singh Purewal. The firm crushes and processes riverbed material (RBD), boulders into stone chips, stone grits and sandstone that find usage in the construction industry.

Status of non-cooperation with previous CRA: ICRA has continued the ratings assigned to the bank facilities of PSC into 'Issuer not-cooperating' category vide press release dated September 15, 2025 on account of non-availability of requisite information from the company.
