Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated July 11, 2025, placed the rating(s) of Milando Fashions Limited (MFL) under the 'issuer non-cooperating' category as MFL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. MFL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated May 27, 2026, June 06, 2026, June 16, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

About the company

Milando Fashions Limited formerly known as Koursain Exports Limited (KSEL), based in Ludhiana (Punjab), was incorporated in 2001 as a public limited company. The company is currently being managed by Mr. Amneesh Bansal and Mr. Rajneesh Bansal. KSEL is engaged in manufacturing of hosiery garments at its manufacturing facility located in Ludhiana, Punjab. The product line includes men's T-shirts, shirts, track suits, lowers, etc. The company sells its products PAN India through wholesalers. It also exports its products to U.S.A., South Africa and Middle East.

Status of non-cooperation with previous CRA: India Ratings has continued the ratings assigned to the bank facilities of MFL into 'Issuer not-cooperating' category vide press release dated November 24, 2025 on account of non-availability of requisite information from the company.
