Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated July 28, 2025, placed the rating(s) of S S S Fibre Private Limited (SSSFPL) under the 'issuer non-cooperating' category as SSSFPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SSSFPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 13, 2026, June 24, 2026, July 03, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

The ratings assigned to bank facilities of SSSFPL have been revised on account of non-availability of requisite information.
