Rationale & Key Rating Drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated July 23, 2025, placed the rating(s) of Sanghi Brothers (Indore) Private Limited (SBPL) under the 'issuer non-cooperating' category as SBPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SBPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 08, 2026, June 18, 2026, June 29, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

SBPL was incorporated in the year 1950 by Late Shri Sohanlal G Sanghi. SBPL is the authorized dealer of TATA Motors Limited (TML) for Indore and Bhopal territory of Madhya Pradesh (MP) state since 1954. Overall operations of the company are looked after by the Chairman and Managing Director, Mr Sharad Kumar Sanghi. Apart from its flagship automobile dealership business, SBPL is also engaged in sale of spare parts, travel services and operating its metal division & renewable energy (wind mill) division.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of SBPL into ISSUER NOT COOPERATING category vide press release dated October 23, 2025 on account of its inability to carry out a review in the absence of requisite information from the company.
