Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated August 11, 2025, placed the rating(s) of G And T Industries Private Limited (GTIPL) under the 'issuer non-cooperating' category as GTIPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. GTIPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 29, 2026, July 07, 2026, July 17, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

About the company

Tamil Nadu based, G and T Industries Private Limited (GTIPL) was established in the year 2013 as Private Limited Company, promoted by Mr. G. Prakash Kumar and family. GTIPL plant is located at Pulliline Village, Varalakshmi Nagar, Vadaperumbakkam, Chennai, Tamil Nadu. The company is engaged in manufacturing of electrical wires like copper wires, winding wires and aluminum wires with an installed capacity of 200 MT per month. The company started its commercial operations from October 2016.

Status of non-cooperation with previous CRA: CRISIL has continued the ratings assigned to the bank facilities of GTIPL to the 'issuer not-cooperating' category vide press release dated February 25, 2026 on account of its inability to carryout review in the absence of requisite information from the company.
