Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated July 18, 2025, placed the rating(s) of Raj Kumar Jain (RKJ) under the 'issuer non-cooperating' category as RKJ had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. RKJ continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 03, 2026, June 13, 2026, June 25, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Guwahati based, Raj Kumar Jain (RKJ) was set up as a proprietorship firm in 1980 by Mr. Raj Kumar Jain and later it converted to as a partnership firm in April 2006. Since its inception, the firm has been engaged in civil construction business in the segments like construction of roads, bridges etc. Currently the firm is being managed by three partners, namely Mr. Raj Kumar Jain, Mr. Ritesh Kumar Jain and Mr. Piyush Jain. The firm procures orders through tenders and executes orders floated by the various Govt. entities.

Status of non-cooperation with previous CRA: Acuite has continued the ratings assigned to the bank facilities of RKJ to the 'issuer not-cooperating' category vide press release dated July 09, 2025 on account of its inability to carryout review in the absence of requisite information from the firm.
