### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated July 18, 2025, placed the rating(s) of Rukmani Retails Private Limited (RRPL) under the 'issuer non-cooperating' category as RRPL had failed to provide information for monitoring of the rating exercise as agreed to in its Rating Agreement. RRPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 03, 2026, June 13, 2026, June 25, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Indore (Madhya Pradesh) based RRPL was incorporated in the year 2006 by Khandelwal family under the name of Rukmani Engineering Private Limited. Subsequently, the name of the company was changed to RRPL during November, 2007. Earlier, the company was engaged in the trading of pipes and fittings and from FY17 onwards, RRPL commenced manufacturing of Water Storage Tanks and other PVC pipes which finds its application in various industries for different purposes such as storing chemicals, water, liquid etc.
