Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated June 13, 2025, placed the rating(s) of Guna Poultry Feeds (GPF) under the 'issuer non-cooperating' category as GPF had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. GPF continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 29, 2026, May 09, 2026, May 19, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

About the Firm

Guna Poultry Feeds (GPF) was established in the year 2002 as proprietorship firm by Mrs. R. Gunavathi. The firm is engaged in manufacturing of poultry feed with an installed capacity of 40 tons per day at Rajagoundanur, Namakkal, Tamil Nadu. The firm is also engaged in trading of eggs. The firm purchases major raw materials (Maize, Soya) from the local dealers in and around Namakkal. The firm sells the poultry feeds to its associate concern Rajamanickam Poultry Farm (RPF) (75% of total poultry feed sales) and other local poultry farms (25% of total poultry feed sales). The firm purchases eggs from RPF and sells them to local traders.

Status of non-cooperation with previous CRA: CRISIL has continued the ratings assigned to the bank facilities of GPF to the 'issuer not-cooperating' category vide press release dated September 12, 2025 on account of its inability to carryout review in the absence of requisite information from the firm.
