Rationale & Key Rating Drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated July 31, 2025, placed the rating(s) of Alvi Tech Services Private Limited (ATSPL) under the 'issuer non-cooperating' category as ATSPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. ATSPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 16, 2026, June 26, 2026, July 06, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.
