Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated August 01, 2025, placed the rating(s) of Creative Clothex (CC) under the 'issuer non-cooperating' category as CC had failed to provide information for monitoring of the rating and had as agreed to in its Rating Agreement. CC continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 17, 2026, June 29, 2026, July 07, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Noida, Uttar Pradesh based, Creative Clothex (CC) was originally established in 1995 as a proprietorship concern and is currently being managed by Mrs. Geeta Singhal. The firm is engaged in manufacturing of readymade garments such as sportswear and casual wear (shorts, jackets, track suits, track pants, t-shirts etc.) for men and women.

Status of non-cooperation with previous CRA: India Ratings has continued the rating assigned to the bank facilities of CC into Issuer Not Cooperating category vide press release dated April 02, 2026 on account of its inability to carry out a review in the absence of requisite information.
