Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated August 04, 2025, placed the rating(s) of Patliputra Equipments Private Limited (PEPL) under the 'issuer non-cooperating' category as PEPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. PEPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 20, 2026, June 30, 2026, July 10, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

The ratings assigned to the bank facilities of PEPL have been revised on account of non-availability of requisite information.

About the company

PEPL was promoted in June 2006 by Bihar based late Mr. Arunodaya Kumar. PEPL is an authorised dealer of JCB for heavy earthmoving equipment and spare parts in Patna region of Bihar. PEPL is also involved in servicing of these machines and equipment that are usually sold with annual maintenance contracts. It operates through 14 branches, two dedicated showrooms (Muzaffarpur, Patna) which has sales, service and spares (3S) facilities and three workshop (Bihta, Biharsharif, and Hathidah).

Status of non-cooperation with previous CRA: Brickwork has continued the rating assigned to the bank facilities of PEPL into ISSUER NOT COOPERATING category vide press release dated October 17, 2025 on account of its inability to carry out a review in the absence of requisite information from the company.
