CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated July 24, 2025, placed the rating(s) of Prakash Hi-Tech Developers And Constructions Private Limited (PHDCPL) under the 'issuer non-cooperating' category as PHDCPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. PHDCPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 09, 2026, June 19, 2026, June 29, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.
