Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated July 08, 2025, placed the rating(s) of DGP Steel Star Engineering Private Limited (DSSEPL) under the 'issuer non-cooperating' category as DSSEPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. DSSEPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated May 24, 2026, June 03, 2026, June 13, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

DGP Steel Star Engineering Private Limited was initially established as a partnership firm by Mr. Partha Sarathi Mukherjee and Mr. Sandip Mukherjee however, the same was converted into private limited company in the year 1990 with its office located at Durgapur, West Bengal. Since its inception the company is engaged in civil engineering works mainly undertakes fabrication, piping and various structural works on behalf of government departments and other reputed public sector units Mr. Partha Sarathi Mukherjee (Director) and Mr. Sandip Mukherjee (Director) has more than three decades of experience in civil construction industry. They look after the day to day operations of the entity along with other technical and nontechnical professionals who are having long experience in this industry.

Status of non-cooperation with previous CRA: CRISIL has continued the rating assigned to the bank facilities of DSSEPL into ISSUER NOT COOPERATING category vide press release dated September 17, 2025 on account of its inability to carry out a review in the absence of requisite information from the company.
