Rationale & Key Rating Drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated July 16, 2025, placed the rating(s) of Essbee Enterprises (EE) under the 'issuer non-cooperating' category as EE had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. EE continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 01, 2026, June 11, 2026, June 21, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

About the company

Mumbai (Maharashtra) based Essbee Enterprises (EE) was formed as a partnership concern in 1992 by Mr. Godmal V. Panani, Mr. Mahendra G. Panani and Mrs. Ranjan H. Panani. Further Mr. Godmal V Panani has retired from the business as on April, 13, 2016 and new partner Mr. Chetas H. Panani has joined the firm. The entity is engaged in the business of execution of civil construction projects which involve earth work, road work, deep excavation, bridges, hard rock cuttings, land development, drainage system, industrial building (civil work) and various other infrastructure jobs for government entities only whereby it gets orders through bidding process. The entity is registered Class-B approved contractor with MCGM, KDMC, NMMC and MBMC in Maharashtra. The firm procures raw material namely bitumen, crushed stones, gravel, metal, cement etc. from local suppliers.

Status of non-cooperation with previous CRA: CRISIL continues to categorize rating assigned to the bank facilities of EE under non-cooperation category vide PR dated August 21, 2025 on account of its inability to carry out a rating surveillance in the absence of the requisite information from the company.
