Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated July 21, 2025, placed the rating(s) of Shanker Plastic Products (SPP) under the 'issuer non-cooperating' category as SPP had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SPP continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 06, 2026, June 16, 2026, June 26, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Shanker Plastic Products (SPP), an ISO 9001:2008 certified firm was established in November, 2012 as a proprietorship firm by Mr. Parveen Sharma. The firm is engaged in manufacturing of plastic water tanks at its manufacturing facility located in Samba, Jammu and Kashmir.

Status of non-cooperation with previous CRA: CRISIL has moved the rating assigned to the bank facilities of SPP into Issuer Not Cooperating category vide press release dated November 05, 2025 on account of its inability to carry out a review in the absence of requisite information.
