Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated July 15, 2025, placed the rating(s) of Shakti Earth Movers (SEM) under the 'issuer non-cooperating' category as SEM had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SEM continues to be non-cooperative despite repeated requests for submission of information through e-mails dated May 31, 2026, June 10, 2026, June 20, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

About the Firm

Mandideep-based (Madhya Pradesh) SEM was established in October, 1992 as a proprietorship firm by Mr. Shiv Singh Chouhan. SEM mainly executes projects for civil construction of roads, largely for the Government of Madhya Pradesh. Further, SEM is also engaged into loading and unloading of construction materials for private entities. Proprietor of SEM is having an experience of around more than two decades in the same industry.

Status of non-cooperation with previous CRA: CRISIL has continued the ratings assigned to the bank facilities of SEM to 'Issuer Not Cooperating' category vide press release dated July 18, 2025 on account of its inability to carry out a review in the absence of the requisite information from the firm.
