Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated August 05, 2025, placed the rating(s) of Balaji Enterprises-Lucknow (BE) under the 'issuer non-cooperating' category as BE had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. BE continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 21, 2026, July 01, 2026 and July 11, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Lucknow (Uttar Pradesh (UP) based Balaji Enterprises (BE) was established in 2008 as a partnership concern by Mr Navneet Kumar Pandey, Mr Nirmal Kumar Pandey and Mr Vinay Kumar Pandey. It is engaged in toll collection activity at Dakshina Shekhpur, Aadityapur Kandra and Maranga Toll Plaza in UP. Further BEL has undertaken its Real-Estate Project named 'Landmark' with total saleable area of 123070 Sq. Feet having 73 flats consisting of 33 flats of 2BHK, 35 flats of 3BHK, 3 flats of 4BHK and 2 penthouse in Lucknow with an average sale value of Rs 3072 per sq. feet.
