### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated July 25, 2025, placed the rating(s) of Divine Infrastructure (DI) under the 'issuer non-cooperating' category as DI had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. DI continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 10, 2026, June 20, 2026, June 30, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

### About the Firm

Tikamgarh (Madhya Pradesh, MP) based DI was formed as a partnership firm by Mr. Pranav Jaiswal and Mr. Anshul Khare. DI is registered as 'A5' class contractor and is engaged in Government civil construction for construction of roads, buildings, bridge and tunnels etc. The firm mainly executes civil construction contract for Public Works Department (PWD), MP Rural Road Development Authority and Railway Department.

**Status of non-cooperation with previous CRA:** CRISIL has continued the ratings assigned to the bank facilities of DI to 'Issuer Not Cooperating' category vide press release dated January 21, 2026 on account of its inability to carry out a review in the absence of the requisite information from the firm.
