Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated May 26, 2025, placed the rating(s) of Dishnet Wireless Limited (DWL) under the 'issuer non-cooperating' category as DWL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. DWL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated April 11, 2026, April 21, 2026, May 01, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

About the company

AL, together with two of its wholly owned subsidiaries, ACL and DWL, provides 2G wireless telecom services in all the 22 circles of India and 3G services in 13 circles. DWL, another wholly owned subsidiary of AL, provides mobile banking services. Maxis Communications Berhad (MCB), through Global Communication Service Holdings Limited and Deccan Digital Networks Private Limited, effectively holds ~73.99% equity interest in AL. AL had filed a petition before the NCLT, Mumbai Bench in terms of Section 10 of the Insolvency and Bankruptcy Code, 2016.

Status of non-cooperation with previous CRA: ICRA has continued the ratings assigned to the bank facilities of DWL into 'Issuer not-cooperating' category vide press release dated November 14, 2025 on account of non-availability of requisite information from the company.
