Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated July 30, 2025, placed the rating(s) of K.Koteswara Reddy (KR) under the 'issuer non-cooperating' category as KR had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. KR continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 15, 2026, June 26, 2026, July 05, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Telangana based, K. Koteswara Reddy (KR) was incorporated and started commercial operations in the year 2008 as a proprietorship concern promoted by Mr K. Koteswara Reddy. KR is engaged in construction of Roads, Bridges, Canals for Irrigation projects. The firm majorly gets the contracts from Panchayat Raj's.

Status of non-cooperation with previous CRA: CRISIL has continued the ratings assigned to the bank facilities of KR to the 'issuer not-cooperating' category vide press release dated October 08, 2025 on account of its inability to carryout review in the absence of requisite information from the firm.
