Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated July 21, 2025, placed the rating(s) of K.y.s. Manufacturers & Exporters Private Limited (KMEPL) under the 'issuer non-cooperating' category as KMEPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. KMEPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 06, 2026, June 16, 2026, June 26, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

About the company

KYS Manufacturers and Exporters Private Limited (KMEPL) incorporated in March 1997, was promoted by Mr Sandeep Malhotra and Mr Mahesh Kumar Sharma, Jamshedpur with Mr Sandeep Malhotra being the main promoter. KMEPL is engaged in manufacturing of TMT bars and sectional products like angles, rounds, channels etc. at its manufacturing facility in Jamshedpur (Jharkhand). KMEPL sells its products mainly in the states of Jharkhand, Bihar, Uttar Pradesh and West Bengal.

Status of non-cooperation with previous CRA: Brickwork has continued the rating assigned to the bank facilities of KMEPL into ISSUER NOT COOPERATING category vide press release dated April 30, 2026 on account of its inability to carry out a review in the absence of requisite information from the company.
