Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated August 14, 2025, placed the rating(s) of Parth Thread Private Limited (PTPL) under the 'issuer non-cooperating' category as PTPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. PTPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 30, 2026, July 10, 2026, July 20, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Parth Thread Private Limited (PTPL) was incorporated in 2006, by Mr. Ambika Prasad Pandey, is based out of Kanpur (Uttar Pradesh) & engaged in the manufacturing of cotton yarn, polyester fiber yarn, staple fiber yarn, acrylic yarn, polyester viscose (P/V) blended yarn, acrylic polyester blended yarn (A/P) and cotton viscose blended yarn (C/V). The company also manufactures fancy yarns and dyed yarn in P/V, A/P and C/V. The manufacturing facility is located at Memrejpur, Ambedkar Nagar at Lucknow, Uttar Pradesh.
