Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated August 07, 2025, placed the rating(s) of Periwal Polymers Private Limited (PPPL) under the 'issuer non-cooperating' category as PPPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. PPPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 24, 2026, July 03, 2026, July 13, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

About the company

Alwar (Rajasthan) based PPPL is a private limited company which was incorporated in 1994. The company is currently being managed by Mr Ghanshyam Periwal and Mrs Sarita Aggarwal. PPPL is engaged in manufacturing of PVC granules which find its application in cable industry (for insulation).

Status of non-cooperation with previous CRA: CRISIL continues to categorize rating assigned to the bank facilities of PPPL under non-cooperation category vide PR dated July 28, 2026 on account of its inability to carry out a rating surveillance in the absence of the requisite information from the company.
