Karnataka based, M G Kitchenware (MGK) was established in 2007 as a proprietorship firm by Mr. Manoj Kumar. MGK is engaged in the manufacturing of kitchenware items like Pressure cooker, Aluminum plates, Steel plates, LPG gas stove etc. The firm purchases materials like steel, aluminum, Pressure cooker handles, etc. from the suppliers located in Delhi, Mumbai and Bangalore and sell its final products to the distributors located in Karnataka, Kerala, Andhra Pradesh and Tamil Nadu. The current installed capacity for manufacturing of kitchenware products is 60,000 pieces per month.
