### Rationale & Key Rating Drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated July 25, 2025, placed the rating(s) of Jay Somnath Paper Mill (JSPM) under the 'issuer non-cooperating' category as JSPM had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. JSPM continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 10, 2026, June 20, 2026, June 30, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

### About the Firm

Rajkot-based (Gujarat), JSPM was established in January 2016 by Mr. Rahman Viradiya, Mr. Bakulbhai Viradiya, Mr. Girishbhai Kathiriya, Mr. Vijaybhai Kathiriya, Mr. Jayraj Kathiriya, Mr. Kanthibhai Vagasiya and Mr. Mayur Bhai Movaliyato carry out business of manufacturing kraft paper. JSPM has completed a green-field project to manufacture kraft paper with an installed capacity of 21,000 MT per annum at its manufacturing facilities located at Rajkot, Gujarat. JSPM is commenced operations from end of April 2017 onwards.

**Status of non-cooperation with previous CRA:** CRISIL has continued the rating assigned to the bank facilities of JSPM into Issuer Not Cooperating category vide press release dated December 08, 2025 on account of its inability to carry out a review in the absence of the requisite information from the firm.
