CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated August 06, 2025, placed the rating(s) of OM Circuit Boards Private Limited (OCBPL) under the 'issuer non-cooperating' category as OCBPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. OCBPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 22, 2026, July 02, 2026, July 12, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.
