PE continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 13, 2026, June 24, 2026, July 03, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

The firm is mainly engaged in manufacturing and exports of knitted and woven garments since inception. The firm purchase yarn and converting into fabric by giving job work. The manufacturing process contains knitting, bleaching, and dyeing are executed by job work basis. Cutting and stitching and printing of garments done by PE. The main products of the firm are hosiery garments from which the firm is generating more than 95% of the total operating income derived through exports to countries like France, UK, and Dubai.
