Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated August 18, 2025, placed the rating(s) of Shivanshu Sintered Products Private Limited (SSPPL) under the 'issuer non-cooperating' category as SSPPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SSPPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated July 04, 2026, July 14, 2026, July 24, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.
