### Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated August 07, 2025, placed the rating(s) of North Street Cooling Towers Private Limited (NSCTPL) under the 'issuer non-cooperating' category as NSCTPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. NSCTPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 24, 2026, July 03, 2026, July 13, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

The ratings assigned to bank facilities of NSCTPL have been revised on account of non-availability of requisite information.

### About the company

NSCTPL was established in the year 1989 as a proprietorship entity by Mr Mukesh Bansal of Uttar Pradesh. In 1993, the entity was re-constituted as a private limited company with Mr Mukesh Bansal and Mr Suresh Chandra Aggarwal as directors. The company is engaged in the manufacturing and installation of commercial and industrial cooling towers with its manufacturing facility located at Ghaziabad, Uttar Pradesh.

**Status of non-cooperation with previous CRA:** Brickwork has continued the rating assigned to the bank facilities of NSCTPL into Issuer Not Cooperating category vide press release dated July 03, 2026 on account of its inability to carry out a review in the absence of requisite information.
