Rationale and key rating drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated August 08, 2025, placed the rating(s) of Shivohum Textiles (ST) under the 'issuer non-cooperating' category as ST had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. ST continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 25, 2026, July 04, 2026, July 14, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.
