Rationale & Key Rating Drivers

CARE Ratings Limited (CareEdge Ratings) had, vide its press release dated July 25, 2025, placed the rating(s) of Sarmangal Synthetics Private Limited (SSPL) under the 'issuer non-cooperating' category as SSPL had failed to provide information for monitoring of the rating as agreed to in its Rating Agreement. SSPL continues to be non-cooperative despite repeated requests for submission of information through e-mails dated June 10, 2026, June 20, 2026, June 30, 2026 among others.

In line with the extant SEBI guidelines, CareEdge Ratings has reviewed the rating on the basis of the best available information which however, in CareEdge Ratings' opinion is not sufficient to arrive at a fair rating.

Established in Coimbatore in April 1995, Sarmangal Synthetics Private Limited (SSPL), was promoted by Mr. B. Balchand Bothra, Mr. B. Mahaveer Chand Bothra and Mr. B. Nirmal Kumar Bothra to manufacture Polyester viscose blended yarn (single and double), Polyester yarn, dyed yarn, mélange yarn and fancy yarn. The lender had confirmed that the company has not availed moratorium for its existing bank facilities.
