Detailed Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated June 01, 2021, placed the rating(s) of ITNL Road Infrastructure Development Company Limited (IRIDCL) under the 'issuer non-cooperating' category as IRIDCL had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. IRIDCL continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated April 17, 2022, April 27, 2022, May 07, 2022.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

ITNL Road Infrastructure Development Company Ltd. (IRIDCL) is a Special Purpose Vehicle (SPV) floated by IL&FS Transportation Networks Ltd. (ITNL, rated CARE D; Issuer Not Cooperating) for two-laning of National Highway (NH-8) from 58.245 km to 177.05 km (approximately 116 km) on Gomti – Beawar section in the State of Rajasthan (traversing two districts viz. Ajmer and Rajasmand) on a Design, Build, Finance, Operate and Transfer (DBFOT) basis. CARE does not have any update on the latest developments in this regard.
