Detailed Rationale & Key Rating Drivers

CARE Ratings Ltd. had, vide its press release dated June 23, 2021, placed the rating(s) of Madhav Textiles (MT) under the 'issuer non-cooperating' category as MT had failed to provide information for monitoring of the rating and had not paid the surveillance fees for the rating exercise as agreed to in its Rating Agreement. MT continues to be non-cooperative despite repeated requests for submission of information through e-mails, phone calls and a letter/email dated May 09, 2022, May 19, 2022, May 29, 2022.

In line with the extant SEBI guidelines, CARE Ratings Ltd. has reviewed the rating on the basis of the best available information which however, in CARE Ratings Ltd.'s opinion is not sufficient to arrive at a fair rating.

About the Company

Surat (Gujarat) based MT was established in 2010 as a proprietorship firm by Mr. Akhilesh Maheswari. MT is into the business of trading of yarn (Viscose and Mono Filament) and finished fabrics. MT is also doing job work of finished fabric however proportion of the same is very small. MT imports its material i.e. viscose yarn and mono filament yarn from China and Korea and purchases finished fabric from the local market. These materials are then being supplied to local weavers (in case of yarn) and manufacturer of sarees and readymade garments (in case of finished fabric).
